

## Congressman Pascrell Reacts to Campaign Finance Reform Proposal Unveiled by U.S. Senator Schumer

Pascrell vows to fight to keep foreign influence out of American elections

U.S. Rep. Bill Pascrell, Jr. (D-NJ-8) today released the following statement in response to the campaign finance reform proposal unveiled by U.S. Senator Charles Schumer (D-NY) and U.S. Rep. Chris Van Hollen (D-MD-8). Pascrell is the author of H.R. 4522, the Prohibiting Foreign Influence in American Elections Act, which has 40 bipartisan cosponsors and invokes a zerotolerance standard for foreign corporations making political contributions in American elec-

The proposal presented today

allows corporations with 20 percent foreign ownership to make political contributions.

"The Congress must respond to the flawed Supreme Court decision and make sure American elections are decided by Americans, not multinational corporations. I am pleased that the bicameral proposal includes provisions prohibiting political contributions from foreign companies and subsidiaries," their said Pascrell, a member of the House Ways and Means Committee. "This is the start of the legislative process. I will continue to work with my colleagues so that a complete prohibition of political contributions from foreign sources becomes the law of the land in the strongest form of legislation possible."

For 100 years, corporations and unions have been prohibited from purchasing political advertisements in the final days of a campaign. Last month, the U.S. Supreme Court reversed that prohibition with a 5-4 decision in the Citizens United v. Federal Election Commission case. One of the most egregious effects of this ruling is the creation of a loophole that will allow foreign individuals and countries to spend money on American campaigns by laundering it through corporations they control.

## Open for Business by Nicholas J. Veliky

Governor Chris Christie's approach is just fine. In spite of what you read in local dallies. Tough times call for tough measures and that's exactly what the governor is doing. When we hear of budget shortfalls into the tens and hundreds of millions and the words painful and suffering being uttered by our elected officials, anyone with even the slightest level of intelligence can surmise there will be some unpopular and difficult decisions handed down. No one wants to hear it but we all must realize there is no popularity contest to be won if the job is to be done right. We need to support the governor and at least give him the first 100 days as a "honeymoon" before the press begins to second guess and criticize his actions.

The great Passaic County deer hunt debacle has come to a close for now. First they didn't notify neighbors, now it has been reported that the deer that were culled from the herd (that's a nice way of saying killed or slaughtered) have not been accurately accounted for, so no one really knows how many deer have been taken. And you thought Bambi was the only deer story that could bring a tear to your eye. Who knows, if this keeps up maybe we will have Passaic County deer on the endangered species list before long.

In a memo dated January 11, 2010, Clifton Police Chief Robert Ferreri announced to Clifton City Manager Albert Greco his intention to retire come March First, now a mere two weeks away. The Chief stated that the time was right to make his departure. Word has it that his decision coincides with a change in personnel law that is coming down the pipe which will drastically reduce the amount of accumulated sick time that can be paid out at retirement. In any case the Chief is leaving and the question remains who will take the reigns as top cop in the city of Clifton? The decision to appoint a new Chief lies solely on the shoulders of our City Manager. We understand that he has begun the interview process and will make his decision

It would seem that Clifton's Zoning Officer, Daniel Howell was correct in his determination that the application to convert a home in the Rosemawr section of the city to a Temple should go before the City's Zoning Board of Adjustment. After a lengthy legal challenge Superior Court Judge Garry Rothstadt ruled that the application needs to go before the Clifton Zoning Board of Adjustment. Why would the applicant not want to go before the board in the first place? The plans call for a sanctuary, all purpose room, classrooms and a "food warming area". What exactly is a food warming area? Is this something unique to a temple or is this just another way of saying kitchen? Admitting there is a kitchen in the building would lead one to believe that this facility will be used for social gatherings as well as religious services. Aaah Ha! That's why they didn't want to go before the Zoning Board of Adjustment.

The basis for government in the City of Clifton and an individual's right to speak at public forums are found in freedoms established over 200 years ago. When the idea of allowing the public to speak and limit their time at the podium was first envisioned, there was need for a device to make sure the time allotted to each individual was equal. So a sophisticated device (for its time) was purchased and has been in use ever since. The device, a kitchen timer used commonly to make sure hard boiled eggs were hard and soft boiled eggs were soft and the occasional cake didn't stay in the oven for too long just doesn't cut it anymore when local residents approach looking for their five minutes on the floor. The timer currently in use gives arbitrary allotments of time to speakers addressing the governing body. Just like the timer that

## It's Become a Matter of What We're Able to do

To The Editor:

Would we all like to pay good teachers a good salary? You bet! Can we all afford that right now? No. It's not a matter of what we would like too or even what we need to do. It's become a matter of what we're able to do. Clifton families are suffering and we're just not able to pay our teachers or anyone else in the district any more in the foreseeable future.

Teachers are professionals. So, just like any other professional, their responsibility goes beyond just a 40 hour work week. If it's necessary to put in extra hours they do. If it's necessary to take work home, they do. If it's necessary to develop their professional skills, they do. It makes no difference whether you work in the public or private sector; if you're a professional, this is what's expected. But, teachers do work in the public sector and they're union members as well. They're afforded benefits just not available to the rest of us. These benefits are worth

They can achieve tenure, a guaranteed job for life. This is unheard of in the private sector and that's worth money. They

get free health insurance with dental and prescription that's the envy of anyone in the private sector who typically has to contribute up 25% of their plan's cost if they're even covered at all. This is worth money as well. Yes, there're deductibles and co-pays but they're a wash with private sector plans.

Almost half of our teachers earn more than \$80 thousand a year. The average Clifton taxpayer earns \$50 thousand. Teachers get paid extra for extra-curricular activities, anywhere from around \$700 to \$16 thousand. If they do bus duty, that's an extra \$24 an hour, the hourly rate of a \$50 thousand a year job. Chaperones get paid \$32 an hour. They're afforded longevity, from 3% to 6% extra for just being their. Their year consists of only 10 months. If they teach summer school, that's an extra, \$35 an hour. And, there's even more.

By union contract our highest paid - well over \$125 thousand a year - and most valued teachers aren't teaching math; they aren't teaching science; they aren't teaching humanities; they're teaching phys ed and

driving. You can check out the union contract for yourself. When you do, you'll notice in its almost 50 pages there are page after page defining the union's rights and privileges while our kids are only mentioned once, just once. Something's very wrong here. And, yes, this is a union, not a teacher or kids, contract. So, you can be against the union, against the contract and still be for our teachers and for our

## **Passaic Valley Water Commission Charges Are Out of Control**


Letter to the Editor:

Recently, a Clifton senior citizen called me to tell me about their Passaic Valley Water Commission bill and ask what ₹ we could do about these outrageous charges. For example, this Clifton senior citizen (who lives alone) had a water bill of \$56.53 for the billing period of Oct 14, 2009 to January 8, 2009. (The bill consists of two service charges and two usage charges since the billing period overlapped into 2010 and there was a price increase.) This bill consists of two service charges in the amount of \$45.06 and \$4.15 for a total of \$49.21. The usage portion of the bill was \$6.70 and \$0.62 for a total of \$7.32. The service fee of \$49.21 was 87% of the bill. The service fee is based on the meter size of the pipe which brings the water into your home. In this case the meter size of the pipe was 5/8 inch.Imagine even if this person didn't use one drop of water, the bill still would have been \$49.21.

In my case, my water bill for this same period was \$184.57. My service fees were \$112.66 and \$10.38 for a total of \$123.04. The usage portion of my bill was \$5.20 and \$56.33 for a total of \$61.53. In my home, the meter size of the pipe is 1 inch. So, even if I didn't use one drop of water, my bill still would have been \$123.04. My service fee is was more than two and ½ times greater than a home with a 5/8 inch pipe.

Here are some other interesting facts that I have uncovered about these service fees. According to Passaic Valley Water Commission, the service fees (as I have mentioned) depend on the meter size of the pipe your home has to bring the water into your house. There are three different size pipes in most residential homes: 5/8 inch; ¾ inch, or 1 inch. The price increase for the service fees in 2010 are based on the size of the pipe. If you have a 5/8 inch pipe your service fee increased 4% to \$51.02 per quarter from \$49.05 per quarter in 2009 (in 2008 your service fee was \$46.55 per quarter) - so from 2008 to 2010 your service fee increased 9.6%. If you have a ¾ inch pipe your service fee for 2010 rose 6.3% to \$76.52 per quarter from \$72.00 in 2009 (in 2008 your service fee was \$65.82 -so from 2008 to 2010 your service fee



## Top 10 TIPS for pet owners for healthy safe winters:

1. Never leave your dog or cat alone in a car during cold weather. A car can act as a refrigerator in the wine ter, holding in the cold and causing harm to the animal.

2. Puppies do not tol-

the erate cold as well as adult dogs, and may be difficult to house break during the winter. If y o u puppy appears to be sensitive to the



weather, you may opt to paper-train him inside/or use the indoor POTTY products. If your dog is sensitive to the cold due to age, illness or breed type, take him outdoors only to relieve himself.

- 3. If your dog spends a lot of time in outdoor activities? Increase his supply of food, particularly protein, to keep him—and his fur—in tip-top shape.
- 4. Antifreeze is a lethal poison for dogs and cats. Be sure to thoroughly clean up any spills from your vehicle,

and consider using products that contain propylene glycol rather than ethylene glycol.

5. Animals need a warm place to sleep, off the floor and away from all drafts.

6. If possible, keep your cat inside. Outdoors, felines can freeze, become lost or be stolen, injured or killed. Cats who are allowed to stray are exposed to infectious diseases, including rabies, from other cats, dogs and wildlife.

7. Outdoor cats sometimes sleep under the hoods of cars. When the motor is started, the cat can be injured or killed by the fan belt. If there are outdoor cats in your area, bang loudly on the car hood before starting the engine to give the cat a chance to escape.

8. Never let your dog off the leash on snow or ice, especially during a snowstorm—dogs can lose their scent and easily become lost. Statistics show that more dogs are lost during the winter than during any other season, so make sure

> yours always wears ID tags.

9. Wipe off your dog's legs and stomach when he comes in out of the sleet, snow or ice. He can ingest salt, antifreeze other potentially dangerous chemicals while licking

his paws, and his paw pads may also bleed from snow or encrusted ice.

10. Never shave your dog down to the skin in winter, as a longer coat will provide more warmth. When you bathe your dog in the colder months, be sure to completely dry him before taking him out for a walk. Own a short-haired breed? Get them a coat or sweater with a high collar or turtleneck with coverage from the base of the tail to the belly.

increased 16.3%). If you are as lucky as I am to have a 1 inch pipe your service fee for 2010 rose 4% to \$127.54 per quarter from \$122.64 ( in 2008 your service fee was \$100.51 per quarter - so from 2008 to 2010 your service fee rose 26.9%).

On top of these outrageous service fees, Passaic Valley Water Commission raised the usage charge 10.1% for all Clifton customers to \$1.52 per CCF of water consumed from \$1.38 per CCF in 2009. Imagine, a 10% increase in water usage fees and between a 4% to 6% increase in service fees. Have you received these kinds of increases in your salary in 2010 from 2009? I know senior citizens haven't! I also know that workers in the private sector haven't seen raises in many years!

These outrageous service fees have troubled me for a long time. I have reached out to both the Passaic Valley Water Commission and to the Clifton Commissioners (Gloria Kolodziej and Tom DeVita). No one can give me an reasonable answer as to why the service fee charges are so varied. No once can tell me why customers with a 1 inch pipe pay a service fee of more than two and ½ times greater than customers with a 5/8 pipe. According to many engineers I know, having a larger size pipe only means that you use more water quickly than those with a smaller size pipe so that the water usage would be greater. What can you do about these outrageous charges? Governor Christie has publicly criticized the Passaic Valley Sewage Comm.'s high salaries, outrageous pension benefits and buyout packages and would be interested in hearing about the outrageous fees charged by Passaic Valley Water Commission. Between the outrageous water bills and sewage bills combined with the ever-increasing property taxes, it is no wonder that the number of homes for sale in Clifton is at an all time high and foreclosures are at record numbers. Senior citizens and working families are being driven out of Clifton due to these run-away charges and taxes! The voice of the people must be heard!

## Change Your Attitude Change Your Life: Who Are Saints?

Who are the saints? Are they supportive in our spiritual journey or are they guilty of taking our attention from God? Who needs them and what can they teach a modern woman and man? These are a few of the questions discussed in a recent interview with James Martin, a Jesuit priest who wrote the book, My Life With the Saints.

Father Martin is an international best-selling author and Catholic commentator who has appeared on Fox, MSNBC, CNN, and the BBC. He has been dubbed the "Chaplain of the Colbert Report."

Father Martin shared his point of view about the saints and their presence in our lives with Reverend Pawel Szurek, host, Change Your Attitude...Change Your Life.

Following are excerpts from the interview with James Martin:

Who are saints?

Saints are our patrons and our companions. They are wonderful images in theology and tradition.

Why are saints venerated? Why do we need saints if we have Jesus and God?

Saints are like our elder brothers and sisters who help us along the way. They don't take the place of the parents. The saints would be the first people that tell you they're not standing in the place of God. God has given us these examples of these wonderful people who help us understand that being a saint means being exactly who you are and that you don't have to be exactly the same as anyone else to be holy.

Tell me something about your book My Life With the Saints?

The book is the story of my relationship with my favorite saints. Each chapter talks about how I first encountered the saints, about their lives, and what their lives mean to contemporary believers and even to

doubters and seekers.

Can believing in saints be more an act of superstition rather than faith? For example, the practice of burying a statue of St. Joseph to help sell a home.

If you are dealing with a real connection or desire for St. Joseph to pray for you or to help you and if you ask St. Joseph for his prayers, that's part of faith, that's a very faith filled thing to do. If it helps you to remember a saint by using a statue that's fine. If you just bury a statue and if you think that something magical will happen, then it's superstition.

Are saints exclusively connected to the Catholic Church?

Saints are not just for Catholics. If you look at the apostles, they are saints for every Christian tradition. There is no Christian tradition that doesn't look at Saint Peter and the apostles and the evangelists, Matthew, Mark, Luke and John. Those people are common to all of

the Christian traditions. Sanctity is not the product of just one denomination.

Can saints communicate with us?

I think they communicate with us, maybe not directly, but we can be inspired by them in a sense that their stories can lead us. They can pray for us and in a more poetic way, they communicate with us through their lives. When you read about the life of a saint, in a sense you are communicating with them. Their lives are almost like a song, a song that they sing. Someone once said that the saints are like life actors and their script is the gospel. That's a way of communication.

What can we learn from the saints?

Each saint really reveals something different. Look at someone like blessed John XXIII who was Pope from 1958 to 1963, and take the message that it's wonderful to be a humorous person, you can have a sense of joy.

Saint Therese of Lisieux had a message that it is wonderful to do small things with great love. Saint Peter teaches us that it is ok to make mistakes and that Christ will still love you. Even though these lives are far removed from us, in terms of time and their lifestyle, each of their stories can tell us something


unique about the human SDER condition. God gives us these different examples to help us understand life.


